#### CORPORATE OVERVIEW

Harvest Portfolios Group Inc. ("Harvest") is a Canadian Investment Manager focused on unique income generating investment products. Harvest was founded in 2009 and is focused on developing investment products that follow three investment criteria:

- 1. Clear investment objectives
- 2. Transparency
- 3. Income generation

Harvest endeavours to develop investment products that are clear in their mandate and easy for our investors to understand. We strive to be transparent, so that our investors can open their financial reports and know exactly what they own. Our funds are also invested to provide investors with consistent monthly or quarterly income; therefore, we seek to invest our fund portfolios in well managed companies that have a history of steady cash flow and pay dividends.

#### INVESTMENT PRODUCT

The Energy Leaders Income Fund ("the Fund") invests in a portfolio of Equity Securities of 15 Energy Issuers listed on a North American stock exchange (the "Energy Issuers Investable Universe") that have the following characteristics:

- a market capitalization of at least \$10 billion determined at the time of investment;
- are currently paying a dividend/distribution;
- are eligible to have options written on their Equity Securities; and
- have operations and/or offices in at least two countries.



#### PRESIDENT'S MESSAGE

Dear Valued Unitholder,

In 1985 I started my career in the investment business as an advisor; two years later in 1987 the markets suffered their worst one day loss since 1929. That was a difficult time for all investors but there were many lessons to be learned over the next several years. I learned that investments in products that are transparent and businesses that I understood could result in long term gains despite market volatility.

As a unitholder of Harvest it is important to understand our philosophy. The three guiding principles we use when developing our products are:

During my 30 years in the business, I have never seen the volatility and technological influences that move markets like we see today and it is likely here to stay. Regardless, these factors don't change the basics of fundamental investing and Harvest's focus on products that meet your needs. Our goal is to establish products invested in good quality companies that can provide solid returns over the long term.

As we look forward, we want to assure our investors that Harvest will remain committed to its philosophy and appreciate the confidence you have placed in us by investing with us.

### MANAGEMENT DISCUSSION OF FUND PERFORMANCE

The management report of fund performance contains financial highlights but does not contain the complete annual financial statements of the Fund. #### INVESTMENT OBJECTIVES AND STRATEGY

The Fund's investment objectives are to provide unitholders with:

- (i) monthly cash distributions;
- (ii) the opportunity for capital appreciation; and
- (iii) lower overall volatility of portfolio returns than would otherwise be experienced by owning Equity Securities of the Energy Issuers directly.

To seek to achieve its investment objectives, the Fund will invest in Equity Securities of 15 energy issuers from the Energy Issuers Investable Universe that have the following characteristics:

- a market capitalization of at least \$10 billion determined at the time of investment;
- are currently paying a dividend/distribution;
- are eligible to have options written on their Equity Securities; and
- have operations and/or offices in at least two countries.

The Fund manager, Harvest Portfolios Group Inc. ("Harvest") has retained Highstreet Asset Management Inc. ("Highstreet" or "Investment Manager") to provide investment management services to the Fund.

In order to seek to generate additional returns, the Investment manager will sell call options each month on up to 33% of Equity Securities held in the Fund. Such call options may be either exchange-traded options or over-the-counter options.

The Investment Manager will acquire 15 Equity Securities of Energy Issuers for the Fund, and thereafter rebalance quarterly on an equally weighted basis within 15 business days following the last business day of March, June, September and December. Equity Securities of an Energy Issuer will be replaced for the Fund at the time of each quarterly rebalancing only if:

- i) an Energy Issuer no longer has a market capitalization of at least \$10 billion;
- ii) an Energy Issuer has publicly announced that it will cease the payment of its dividend/distribution;
- iii) the Investment Manager, in its discretion, is no longer able to write call options on the Equity security of an Energy Issuer on terms acceptable to the Investment Manager; or
- iv) an Energy Issuer ceases to have operations and/or offices in at least two countries.

In such circumstances, the Equity Security that is removed from the Fund will be replaced with another Equity Security from the Energy Issuers Investable Universe at the discretion of the Investment Manager. At the time of any rebalancing, it is the Investment Manager's intention to acquire a new Equity Security for the Fund only when an Equity Security needs to be replaced.

## **RISK**

The risks associated with investing in the Fund are as described in the prospectus. There were no material changes to the Fund over the period that affected the overall level of risk of the Fund.



#### RESULTS OF OPERATIONS

The Fund returned -17.71% for the year ending December 31, 2014. Following a strong first six months of the year, crude oil prices were extraordinarily volatile during the latter part of 2014. Innovations in horizontal drilling and fracking techniques in recent years has resulted in improved productivity and allowed for resources that were previously uneconomic to be produced. This has increased the supply and inventory levels in particular in North America. This, coupled with enhanced geopolitical uncertainty with OPEC's decision to maintain relatively high production levels and quotas, resulted in the price of crude oil declining dramatically in the second half of the year. This put significant downward pressure across energy related equities around the world. The underlying holdings in the Energy Leaders Income Fund were not immune and consequently many of the underlying holdings within the Fund were subject to price declines which impacted the overall performance during the period.

The Fund sold call options on underlying holdings held in the Portfolio during the period in order to meet its investment and income objectives. The Fund removed two of the original 15 Energy Leaders as it no longer qualified as an Energy Leaders and replaced them with Energy Leaders that met specific investment criteria outlined in the prospectus.

#### RECENT DEVELOPMENTS

Effective January 1, 2014, the Fund prepared its financial statements in compliance with International Financial Reporting Standards (IFRS). The Fund adopted this basis of accounting as required by Canadian securities legislation and the Canadian Accounting Standards Board. Previously, the Fund prepared its financial statements in accordance with Canadian generally accepted accounting principles as defined in the Part V of the CPA Canada Handbook ("Canadian GAAP"). The Fund has consistently applied the accounting policies used in the preparation of its opening IFRS statement of financial position at January 1, 2013 and throughout all periods presented in the financial statements, as if these policies had always been in effect.

The Fund renewed a normal course issuer bid program for the period from June 24, 2014 to June 23, 2015, which allows the Fund to purchase up to 212,436 trust units of the Fund for cancellation by way of a normal course issuer bid through the facilities of the Toronto Stock Exchange. During the year ended December 31, 2014, 35,800 (2013 - 19,600) units were purchased for cancellation for \$423,797 (2013 - \$224,585).

On January 14, 2014 the Fund filed a short form prospectus that qualifies the Fund for distribution of warrants. Warrants were issued to unitholders of record on January 23, 2014. A total of 1,907,992 warrants were issued to subscribe for 953,996 units of the fund at a subscription price of \$12.13 per unit. Two whole warrants entitle the holder to purchase one unit on or before 5:00 p.m. (Toronto time) up to July 15, 2014. During the period all warrants issued were exercised to subscribe for 953,996 units for gross proceeds of \$11,571,971.

### RELATED PARTY TRANSACTIONS

There were no related party transactions during the reporting period, except for management fees and other expense reimbursements paid to Harvest, as noted below in Management and Other Fees.

#### MANAGEMENT AND OTHER FEES

The Fund pays its manager, Harvest, a management fee, plus applicable taxes, calculated based on the average weekly net asset value ("NAV") and paid monthly in arrears, based on an annual rate of 1.00%, plus applicable taxes, of the NAV of the Fund. The Manager pays Highstreet, a fee for its portfolio advisory service, from the management fee received from the Fund, calculated on the basis of the Fund's net asset value. The Fund also pays service fees to registered dealers at the rate of 0.40% of the average weekly NAV of the Fund, plus applicable taxes, per annum of the Fund. Service fees are accrued daily and paid monthly to the Manager, who in turn pays the dealers.

At its sole discretion, the Manager may waive management fees or absorb expenses of the Fund. During the year there were no fees waived or absorbed. The management expense ratios of the Fund with and without the waivers and absorptions are reported in the Ratios and Supplemental Data table below.



#### Operating expenses

The Fund is responsible for operating expenses relating to the carrying on of its business, including custodial services, interest, taxes, legal, audit fees, transfer agency services relating to the issue and redemption of units, and the cost of financial and other reports, costs and expenses for the Fund's Independent Review Committee ("IRC"), including fees and expenses of the IRC members and compliance with applicable laws, regulations and policies. The Manager pays for such expenses on behalf of the Fund, except for certain expenses such as interest, and is then reimbursed by the Fund.

#### Other expenses

The Manager will be reimbursed by the Fund for all reasonable costs, expenses and liabilities incurred by the Manager for performance of services on behalf of the Fund in connection with the discharge by the Manager of its duties hereunder. Such costs and expenses may include, without limitation: mailing and printing expenses for reports to unitholders and other unitholder communications; a reasonable allocation of salaries, benefits and consulting fees; independent directors of the Manager and other administrative expenses and costs incurred in connection with the Fund's continuous public offering and other obligations. These expenses are allocated by the Manager on a reasonable basis, across all of the Harvest Portfolios Group Inc. funds, and series of each applicable fund. These expenses were \$135,812 for the year ended December 31, 2014 (2013 - \$179,674) and are included in the unitholder reporting costs on the Statement of Comprehensive Income in the annual financial statements.

During the Fund's initial offering, certain offering expenses such as costs of creating the Fund, the cost of printing and preparing the prospectus, legal expenses of the Fund, certain remuneration to directors and/or officers of the Manager and other out-of pocket expenses incurred by the agents together with the agent's fees payable by the Fund are included in the carrying amount of the Fund's obligation for net assets attributable to holders of redeemable units. At the initial public offering, directors and/or officers of the Manager were remunerated \$26,891.

### RECOMMENDATIONS OR REPORTS BY THE INDEPENDENT REVIEW COMMITTEE

The Independent Review Committee tabled no special reports and made no extraordinary material recommendations to management of the Fund during the year ended December 31, 2014.

#### **Explanatory Notes:**

- 1. Net assets and distributions are based on the actual number of units outstanding at the relevant time. The increase (decrease) from operations is based on the weighted average number of units outstanding over the reporting period. It is not intended that the Fund's net assets per unit table act as a continuity of opening and closing net assets per unit.
- 2. Net assets, at the commencement of operations on May 18, 2012 was \$11.17, net of agents' commissions and issuance costs of \$0.83 per unit.
- 3. Distributions were paid in cash.
- 4. Management expense ratio ("MER") is based on total expenses (excluding commissions and other portfolio transaction costs) of the stated period and is expressed as an annualized percentage of daily average net asset value during the period. The MER for the period December 31, 2014 includes agents' fees and issue costs of \$199,841 related to the warrants issued. The MER for 2012, the year of inception, included agents' fees of \$1,449,000 and issue costs of \$467,820. In both cases these costs are treated as one-time expenses and therefore were not annualized. The MER without these costs is 2.70% for 2014 and 3.05% for 2012.
- 5. The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.
- 6. The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a Fund's portfolio turnover rate, the greater the trading costs payable by the Fund and the greater the chance of an investor receiving taxable capital gains. There is not necessarily a relationship between a high turnover rate and the performance of a Fund.
- 7. Amounts reported for 2014 and 2013 periods are reported in accordance with International Financial Reporting Standards. All other prior periods are reported under Canadian generally accepted accounting principles.



For comparison purposes the S&P 100 Index, in Canadian dollars (the "Index") is used. While the Fund uses this benchmark for long-term performance comparisons, it is not managed relative to the composition of the Index. As a result, the Fund may experience periods when its performance is not aligned with the Index, either positively or negatively. The return of the Index is calculated without the deduction of management fees and fund expenses whereas the performance of the Fund is calculated after deducting such fees and expenses. 


## SECTOR ALLOCATION
