**Investment Objectives**

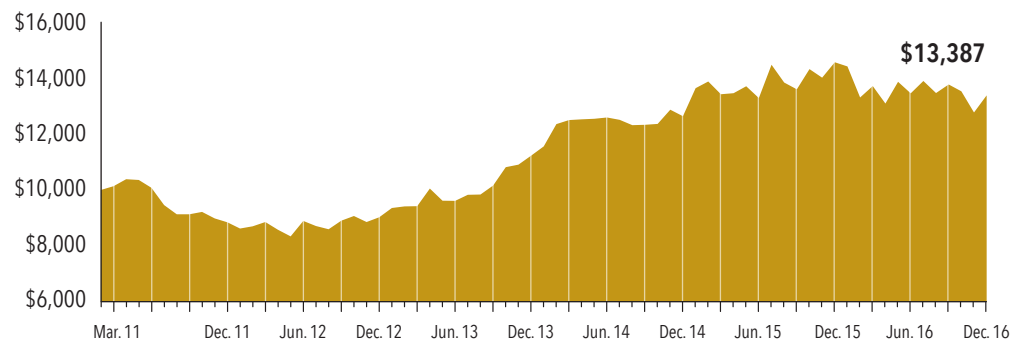

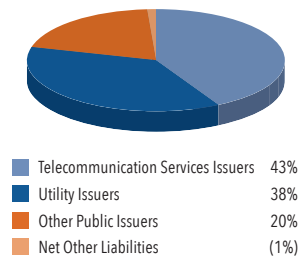

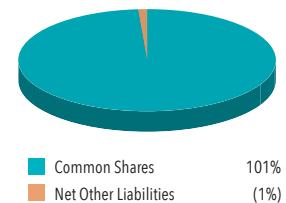
**Cumulative Growth: \$10,000 Invested**
