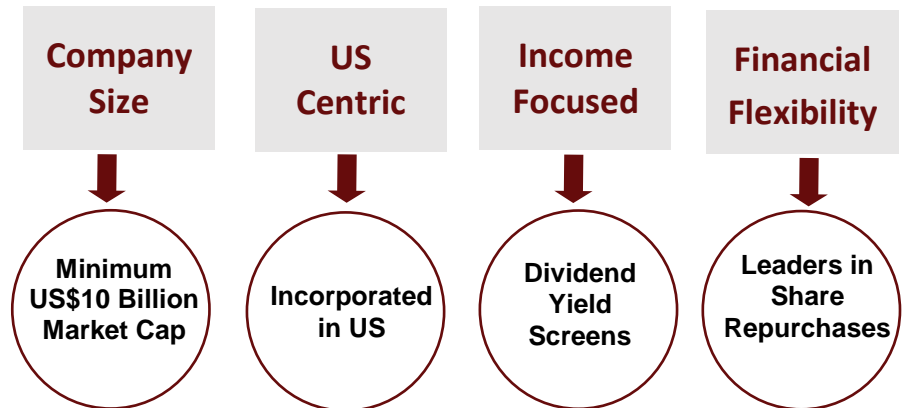

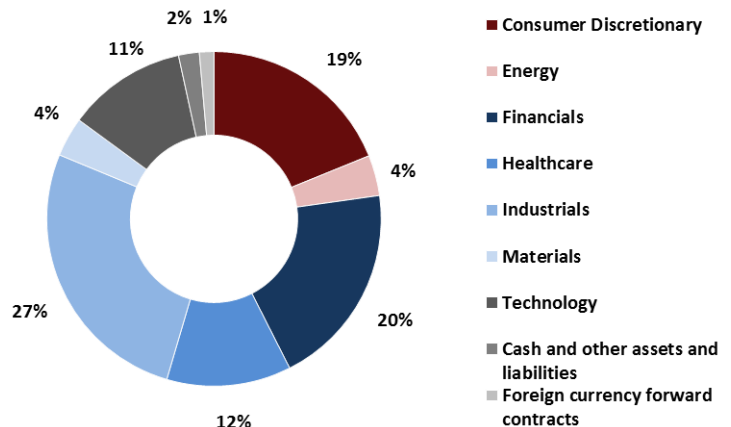
25 S&P 500 Positions Selected Using A Proven Quantitative Process
