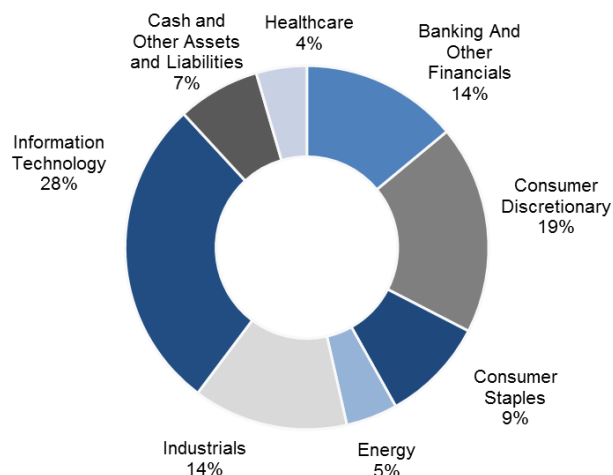
World Class Portfolio of Brand Leaders, as at January 31, 2018
