HARVEST CANADIAN INCOME & GROWTH FUND ANNOUNCES EXCHANGE RATIOS

TORONTO, June 7, 2010 – Harvest Portfolios Group Inc. (the "Manager"), the manager of Harvest Canadian Income & Growth Fund (the "Fund") is pleased to announce the exchange ratios for the exchange offer by the Fund being made under the final prospectus for the Fund dated May 31, 2010 (the "Prospectus").

Prospective purchasers may purchase Units either by (i) cash payment or (ii) an exchange (the "Exchange Option") of each class or series of securities listed in the Prospectus (the "Exchange Eligible Securities"). The number of Units issuable in exchange for an Exchange Eligible Security (the "Exchange Ratio") deposited by a prospective purchaser pursuant to the Exchange Option was determined by dividing the volume weighted average trading price of such securities on the Toronto Stock Exchange during the three consecutive trading days ending on, and including June 7, 2010 (the "Pricing Period"), as adjusted to reflect distributions declared by the applicable Issuer that will not be received by the Fund, by \$12.00. The Exchange Ratios were rounded down to four decimal places. Fractional Units will not be issued by the Fund.

A prospective purchaser of Units was required to deposit its Exchange Eligible Securities with the Exchange Agent through CDS prior to 5:00 p.m. (Toronto time) on May 25, 2010. The closing of the initial public offering of Units by the Fund is expected to occur on June 29, 2010 (the "Closing").

The table below sets out the names of those Exchange Eligible Securities that were deposited prior to the May 25, 2010 deadline, the securities of which may be accepted by the Fund pursuant to the Exchange Option including the applicable Issuer's CUSIP number, ticker symbol, volume weighted average trading price during the Pricing Period and the applicable Exchange Ratio.
