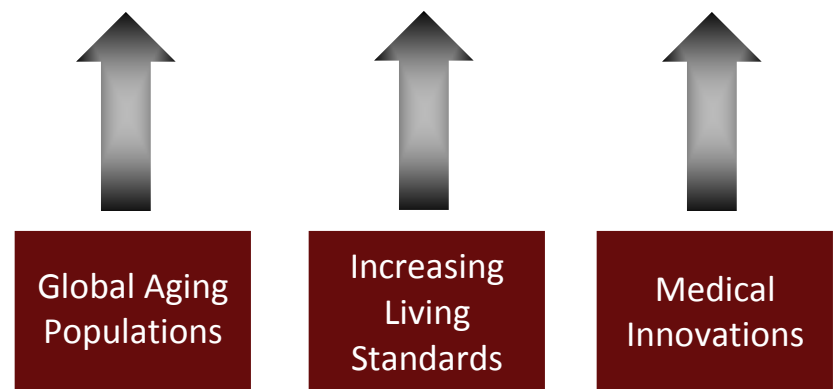

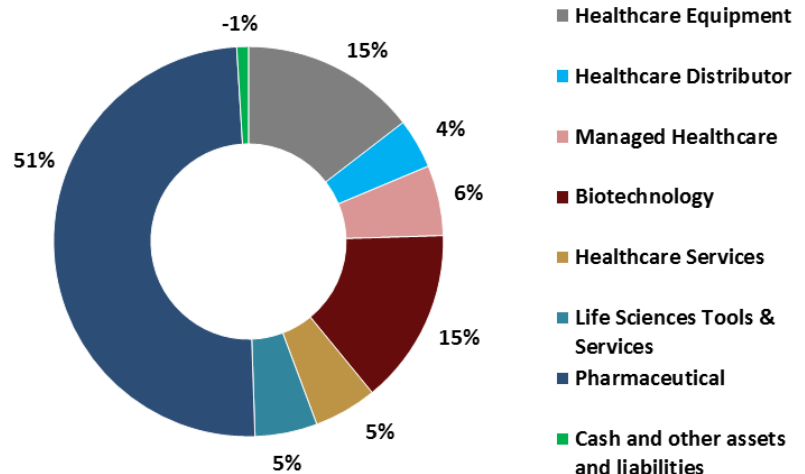
## Permanent & Non-Cyclical Trends Driving Sector
