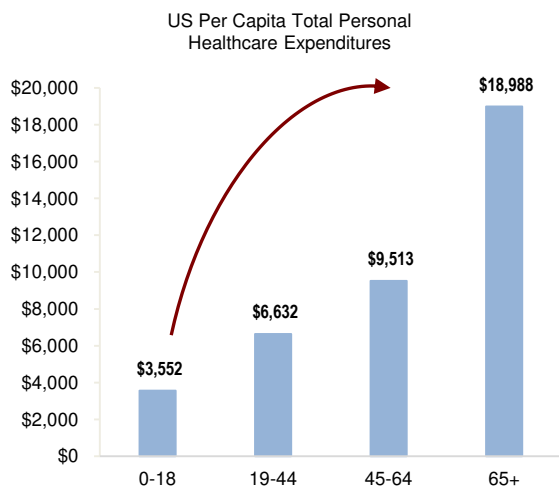

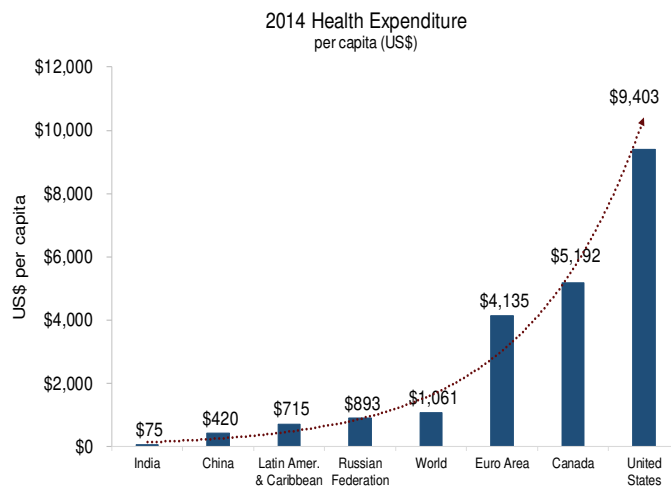
## Permanent & Non-Cyclical Trends Driving Sector

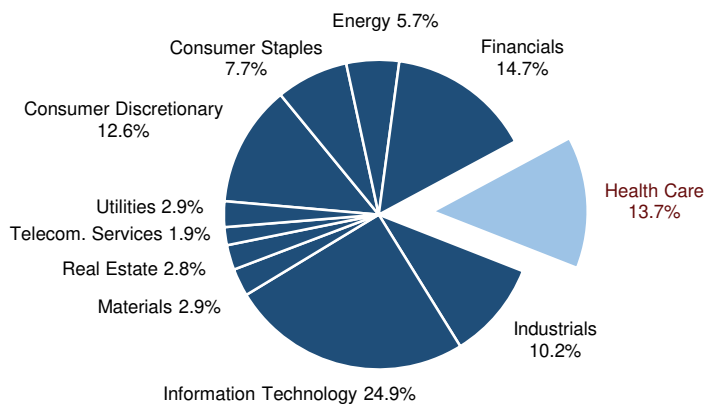
### Healthcare Spending in Developing Markets Increases with Income



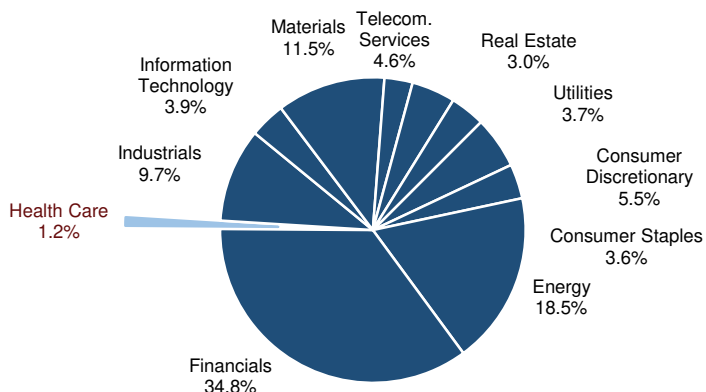

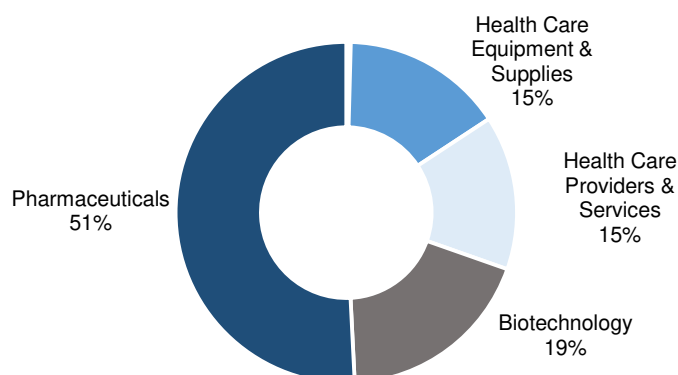

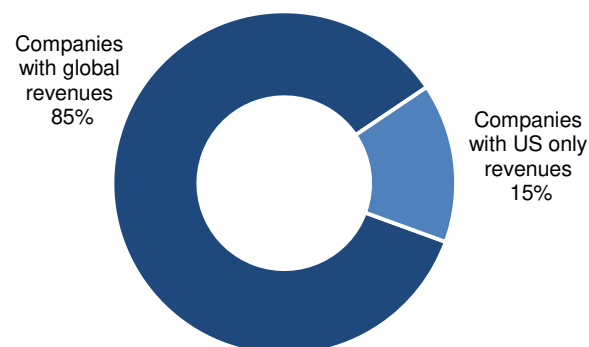
