#### What does the ETF invest in?

The ETF seeks to provide holders of Class A Units with (i) the opportunity for capital appreciation; (ii) monthly cash distributions; and (iii) lower overall volatility of portfolio returns than would otherwise be experienced by owning Equity Securities of the Energy Leaders directly. To achieve lower overall volatility of portfolio returns, the ETF will generally write covered call options on up to 33% of the portfolio securities. The level of covered call option writing may vary based on market volatility and other factors.


## Harvest Energy Leaders Plus Income ETF - Class A Units (HPF)

#### How has the ETF performed?

#### Average return

A person who invested \$1,000 in the Class A Units of the ETF since inception would have had \$834 as of April 30, 2023. This is equal to an annual compounded return of approximately -2.11%.

#### **Trading ETFs**

ETFs hold a basket of investments, like mutual funds, but trade on exchanges like stocks. Here are a few things to keep in mind when trading ETFs:

#### **Pricing**

ETFs have two sets of pricing: market price and net asset value (NAV).

#### Market price

- ETFs are bought and sold on exchanges at the market price. The market price can change throughout the trading day. Factors like supply, demand, and changes in the value of the ETF's investments can affect the market price.
- You can get price quotes any time during the trading day. Quotes have two parts: bid and ask.
- The bid is the highest price a buyer is willing to pay if you want to sell your ETF units. The ask is the lowest price a seller is willing to accept if you want to buy ETF units. The difference between the two is called the "bid-ask spread".
- In general, a smaller bid-ask spread means the ETF is more liquid.
   That means you are more likely to get the price you expect.

## Net asset value (NAV)

- Like mutual funds, ETFs have a NAV. It is calculated after the close
  of each trading day and reflects the value of an ETF's investments at
  that point in time.
- NAV is used to calculate financial information for reporting purposes
   like returns shown in this document.

#### **Orders**

There are two main options for placing trades: market orders and limit orders. A market order lets you buy or sell units at the current market price. A limit order lets you set a price at which you are willing to buy or sell units.

#### **Timing**

In general, market prices of ETFs can be more volatile around the start and end of the trading day. Consider using a limit order or placing a trade at another time during the trading day.
