### What does the ETF invest in?

The ETF seeks to provide holders of Class A Units with (i) long-term capital appreciation through purchasing and holding, on a levered basis, common stock of Amazon.com, Inc. and (ii) high monthly cash distributions. To achieve its investment objectives, the ETF will write covered call options on shares of Amazon.com, Inc., including shares acquired with borrowings. The proportion of covered call options written will vary depending on market conditions and will be based on the ETF's distribution policy, subject to a maximum 50% write level.

Leverage will be created through the use of cash borrowings or as otherwise permitted under applicable securities legislation. The aggregate exposure of the ETF to cash borrowing will be approximately 25% of the ETF's net asset value.

## How much does it cost?
