This ETF is an alternative mutual fund. It has the ability to invest in asset classes or use investment strategies that are not permitted for other types of mutual funds. The specific features that differentiate this fund from other types of mutual funds include the ability to invest more than 10% of its net asset value in securities of a single issuer, the ability to borrow cash, to short sell beyond the limits prescribed for conventional mutual funds and to employ leverage. While these specific strategies will be used in accordance with the ETF's investment objectives and strategies, during certain market conditions they may accelerate the pace at which your investment decreases in value.

Before you invest, consider how the ETF would work with your other investments and your tolerance for risk.

#### What does the ETF invest in?

The ETF seeks to provide securityholders with (i) long-term capital appreciation through purchasing and holding (directly or indirectly), on a levered basis, common stock of Cameco Corporation and (ii) high monthly cash distributions. To achieve its investment objectives, the ETF will write covered call options on shares of Cameco Corporation, including shares acquired with borrowings. The proportion of covered call options written will vary depending on market conditions and will be based on the ETF's distribution policy, subject to a maximum 50% write level.

Leverage will be created through the use of cash borrowings or as otherwise permitted under applicable securities legislation. The aggregate exposure of the ETF to cash borrowing will be approximately 25% of the ETF's net asset value.

# How Risky is it?

The value of the ETF can go down as well as up. You could lose money.

One way to gauge risk is to look at how much the ETF's returns change over time. This is called "volatility".

In general, ETFs with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. ETFs with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

## Risk Rating

Harvest has rated the volatility of this ETF as **medium to high**. Because this is a new ETF, the risk rating is only an estimate by Harvest.

The rating is based on how much the ETF's returns have changed from year to year. It doesn't tell you how volatile the ETF will be in the future. The rating can change over time. An ETF with a low risk rating can still lose money.

# Trading ETFs

ETFs hold a basket of investments, like mutual funds, but trade on exchanges like stocks. Here are a few things to keep in mind when trading ETFs:

## **Pricing**

ETFs have two sets of pricing: market price and net asset value (NAV).

## **Market price**

- ETFs are bought and sold on exchanges at the market price. The market price can change throughout the trading day. Factors like supply, demand, and changes in the value of the ETF's investments can affect the market price.
- You can get price quotes any time during the trading day. Quotes have two parts: bid and ask.
- The bid is the highest price a buyer is willing to pay if you want to sell your ETF shares. The ask is the lowest price a seller is willing to accept if you want to buy ETF shares. The difference between the two is called the "bid-ask spread".
- In general, a smaller bid-ask spread means the ETF is more liquid.
  That means you are more likely to get the price you expect.

## **Best and worst 3-month returns**

This section shows the best and worst returns for the ETF Shares in a 3-month period over the past calendar years. However, this information is not available because the ETF is new.

### Average return

This section shows the value and annual compounded rate of return of a hypothetical \$1,000 investment in the ETF Shares. However, this information is not available because the ETF is new.

# Net asset value (NAV)

- Like mutual funds, ETFs have a NAV. It is calculated after the close of each trading day and reflects the value of an ETF's investments at that point in time.
- NAV is used to calculate financial information for reporting purposes
  like returns shown in this document.

# **Orders**

There are two main options for placing trades: market orders and limit orders. A market order lets you buy or sell shares at the current market price. A limit order lets you set a price at which you are willing to buy or sell shares.

# **Timing**

In general, market prices of ETFs can be more volatile around the start and end of the trading day. Consider using a limit order or placing a trade at another time during the trading day.

# A word about tax

In general, you'll have to pay income tax on any money you make on an ETF. How much you pay depends on the tax laws where you live and whether or not you hold the ETF in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account.

Keep in mind that if you hold your ETF in a non-registered account, distributions from the ETF are included in your taxable income, whether you get them in cash or have them reinvested.

#### How much does it cost?

This section shows the fees and expenses you could pay to buy, own and sell the ETF Shares. Fees and expenses – including trailing commissions - can vary among ETFs. Higher commissions can influence representatives to recommend one investment over another. Ask about other ETFs and investments that may be suitable for you at a lower cost.

#### 1. Brokerage commissions

You may have to pay a commission every time you buy and sell the ETF Shares. Commissions may vary by brokerage firm. Some brokerage firms may offer commission-free ETFs or require a minimum purchase amount.

#### 2. ETF expenses

You don't pay these expenses directly. They affect you because they reduce the ETF's returns. The ETF's expenses are made up of the management fee, operating expenses and trading costs. The ETF's annual management fee is 0.40% of the ETF's value. As this ETF is new, operating expenses and trading costs are not yet available.

#### 3. Trailing commission

A trailing commission is an ongoing commission. It is paid for as long as you own the ETF. It is for the services and advice that your representative and their firm provide to you. This ETF doesn't have a trailing commission.

#### Other fees

Other fee:	The Manager may charge exchanging or redeeming securityholders of the Harvest ETFs, at its discretion, a fee of up to 2% of the exchange or redemption proceeds to offset certain transaction costs associated with the exchange or redemption of the ETF Shares. 	The fee will not be charged to a securityholder in connection with the buying or selling of the ETF Shares on the TSX.

# What if I change my mind?

Under securities law in some provinces and territories, you have the right to cancel your purchase within 48 hours after you receive confirmation of purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the prospectus, ETF Facts or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
