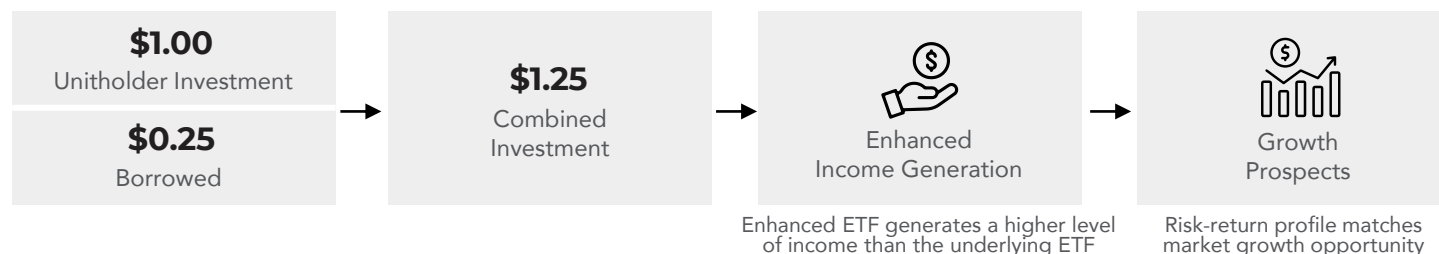
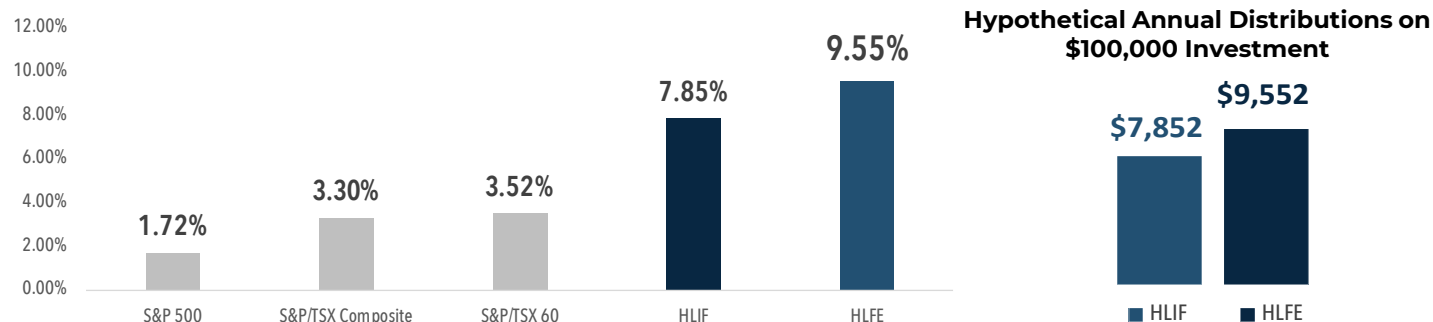


Illustration of Enhanced ETF Yield & Distributions
