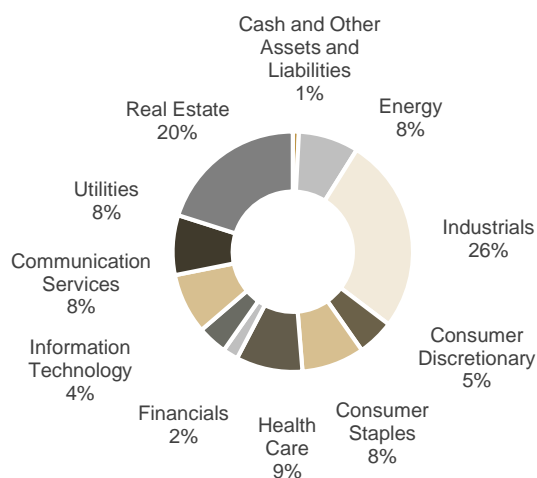

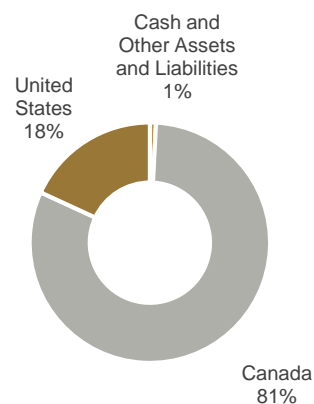
Diversified Portfolio

If these changes had been in effect when the Fund was created, the performance would have been lower.
