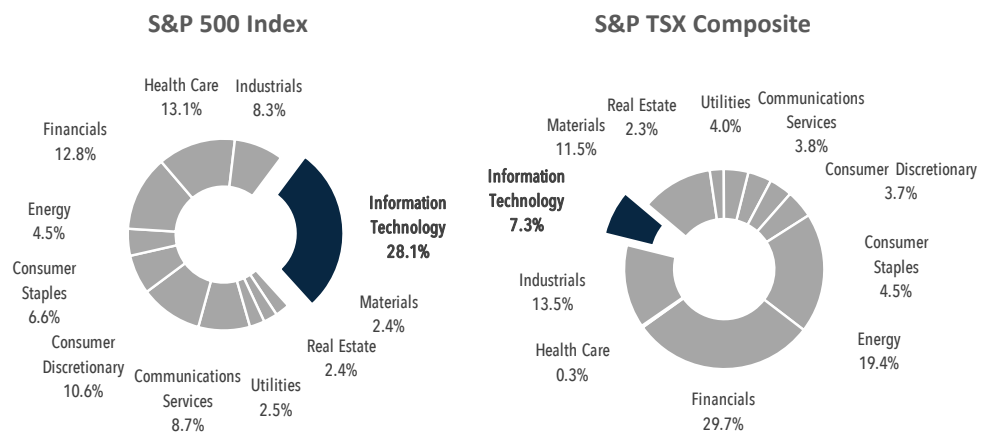

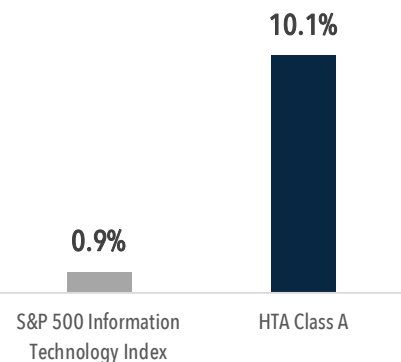
US Tech sector is multiples larger than the entire TSX

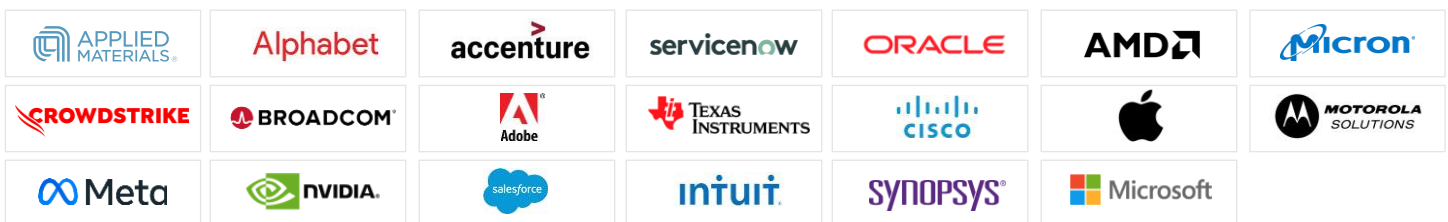
